# GDPR and Data Protection Policy



#### Introduction

This GDPR and Data Protection Policy outlines the procedures and measures adopted by Evergreen Active CIC to ensure compliance with the General Data Protection Regulation (GDPR) and other relevant data protection laws in the United Kingdom. - Data Minimisation: Only the minimum necessary personal data is collected and processed to achieve the intended purpose.
- Accuracy: Reasonable steps are taken to ensure that personal data is accurate, up-to-date, and relevant to the purpose for which it is processed.
- Storage Limitation: Personal data is retained only for as long as necessary to fulfil the purposes for which it was collected.

• Integrity and Confidentiality: Appropriate security measures are implemented to protect personal data against unauthorised access, loss, or disclosure.

## **Types of Personal Data Processed**

Evergreen Active CIC may process various categories of personal data, including but not limited to:

- Contact information (names, addresses, phone numbers, email addresses)
- Health and medical information (injuries, medical conditions)
- Membership and payment details
- Emergency contact information
- CCTV footage for security and safety purposes

# **Data Processing Purposes**

Personal data is processed by the Evergreen Active CIC for the following purposes:

- Membership registration and management
- Facility bookings and reservations
- Event management and communication
- Health and safety purposes
- Marketing and promotional activities (with explicit consent)
- Legal and regulatory compliance

## **Data Subject Rights**

Individuals have the following rights regarding their personal data processed by Evergreen Active CIC:

- Right to access
- Right to rectification
- Right to erasure (right to be forgotten)
- Right to restriction of processing
- Right to data portability
- Right to object
- Right not to be subject to automated decision-making, including profiling

## **Data Security Measures**

Evergreen Active CIC implements appropriate technical and organisational measures to ensure the security and confidentiality of personal data. These measures include:

- Access controls and authentication mechanisms
- Regular security assessments and audits

- Employee training on data protection

#### **Data Sharing and Transfers**

Personal data may be shared with third parties only when necessary for the fulfilment of the stated purposes, such as payment processors, event organisers, and regulatory authorities. Transfers of personal data to countries outside the European Economic Area (EEA) will only occur if there are adequate safeguards in place.

#### Consent

Consent for processing personal data is obtained when required, and individuals have the right to withdraw consent at any time. Consent is documented and stored for reference.

#### **Data Breach Notification**

In the event of a data breach that poses a risk to individuals' rights and freedoms, Evergreen Active CIC will notify the appropriate supervisory authority and affected individuals in accordance with GDPR requirements.

## **Review and Update**

This GDPR and Data Protection Policy will be reviewed and updated periodically to ensure its continued relevance and compliance with applicable data protection laws.
